Arrow, Kenneth J. *Social Choice and Individual Values*. New York: Wiley, 1963. (Nobel prizewinner Arrow was the first to postulate the impossibility of completely satisfying parties with disparate interests, which led to research into sub-optimization.)

Averbach, Bonnie and Orin Chein. *Mathematics: Problem Solving Through Recreational Mathematics*, San Francisco: W.H. Freeman and Co., 1980. (A deceptively light book designed for undergraduate non-mathematics majors – “math for poets.” They emphasize problem solving using mathematics as a tool; the book includes chapters on Logic, Networks and Graph Theory, and Games and Decision Making, which explain the theories behind mathematical models used in analysis.)

Axelrod, Robert. *The Evolution of Cooperation*. New York: Basic Books, 1985. (This is the most complete general book on achieving cooperation in a voluntary association and includes in-depth Prisoner’s Dilemma discussions. Similar writings are far more mathematically-based, however they do not explain these issues as well as Axelrod.)

Brassard, Michael. *The Memory Jogger Plus+*. Methuen, MA: GOAL/QPC, rev. 1996. (Brassard is a practitioner of the total quality management philosophy. His book presents seven practical tools, including affinity diagrams, prioritization matrices, and tree diagrams, that we can easily adapt for executing different phases of the Resource Allocation Decision-Making Framework. Brassard includes examples for each tool’s use and step-by-step implementation guides.)

Braybrooke, David, and Charles E. Lindholm. *A Strategy of Decision*. New York: The Free Press, 1963. (They describe disjointed incrementalism – the bottom-up approach – we use in policy analysis.)

Christensen, Clayton M., *The Innovator’s Dilemma: When New Technologies Cause Great Firms to Fail*. Boston: Harvard business School Press, 1997. (Christensen describes the impact and importance of disruptive technologies and why established companies fail to embrace them.)

Dickson, Douglas N., ed. *Using Logical Techniques for Making Better Decisions*. New York: John Wiley & Sons, 1983. (A compendium of classic articles from the *Harvard Business Review*, including articles on PERT, decision trees and utility theory.)

Dunn, William N. *Public Policy Analysis: An Introduction*, 2nd ed. Englewood Cliffs NJ: Prentice-Hall, 1994. (The best overall text available on public policy analysis; written for the first-year graduate student.)

Etzioni, Amitai. “Mixed Scanning: A ‘Third’ Approach to Decision Making.” *Public Administration Review*, December 1967: pp. 385-392. (Etzioni introduces the approach that combines the top-down and bottom-up approaches in public policy development.)

Fisher, Roger and William L. Ury. *Getting to Yes*. New York: Penguin Books, 1991. (This simple book covers examples of negotiations ranging from those between neighbors to international situations. Fisher and Ury develop a set of rules that structure principled negotiation.)

Garett, Roger A., and J. Phillip London. *Fundamentals of Naval Operations Analysis*. Annapolis: U.S. Naval Institute, 1970. (A primer on operations research and systems analysis with many tactical applications.)

Jones, Archer. *The Art of War in the Western World*. New York: Oxford University Press, 1987. (An excellent force-on-force analytical overview of warfare through the ages that uses models and frameworks extensively to explain the relationships between grand strategies and the interactions of combat arms. An excellent historical perspective on force planning.)

King, Gary, Robert Keohane, and Sidney Verba. *Designing Social Inquiry: Scientific Inference in Qualitative Research*. Princeton: Princeton University Press, 1994. (The authors present a unified approach to descriptive and causal inference in qualitative analysis for public policy decisions. They emphasize cause and effect, effective observation, and avoiding measurement error.)

Kirin, Steve. Executive Summary. *TACWAR Integrated Environment*. Ft. McNair, Va.: U.S. Army Training and Doctrine Command Analysis Center. (The beginning of the user's guide for the most widely used theater-level combat model in DoD.)

Lindholm, Charles E. *The Policy-Making Process*. Englewood Cliffs NJ: Prentice-Hall, 1968. (Explains the tenets of the top-down or rational comprehensive theory in policy analysis.)

Lowe, Christian. "Navy Cut Osprey Tests That Could've Shown Fatal Flaw." *Defense Week*, January 29, 2001: 1.

Mahan, Alfred Thayer. *The Influence of Seapower Upon History 1660-1783*. 12th ed. Boston: Little, Brown & Co., 1890. (A seminal work on seapower that affected many national leaders and their navies at the turn of the last century.)

Manvel, Jr., J. Talbot. "The Next-Generation Aircraft Carrier." *U.S. Naval Institute Proceedings*, Jun. 2000: 70-72.

Mintzberg, Henry. *The Rise and Fall of Strategic Planning*. New York: The Free Press, 1994. (Mintzberg questions the traditional approach to planning and deems it inappropriate for the information age, then suggests how analysis can be used productively in the near future.)

Morse, Philip M., and George E. Kimball. *Methods of Operations Research*. Cambridge, Mass.: MIT Press, 1951. (A classic text by two of the earliest practitioners to use Operations Research to support defense decisions.)

Perla, Peter P. *The Art of Wargaming: A Guide for Professionals and Hobbyists*. Annapolis: Naval Institute Press, 1990. (A general treatise that traces the history of wargaming and discusses its current applications.)

Peters, J.T., K.R. Hammah, and D.A. Summers. "A Note on Intuitive vs. Analytic Thinking." *Organizational Behavior and Human Performance* 12 (1974): 125-131. (Cited in Mintzberg; includes two compelling graphs comparing the results of the two approaches to problem solving.)

Rapoport, Anatol and Albert M. Chammah. *Prisoner's Dilemma*. Ann Arbor: The University of Michigan Press, 1965. (An in-depth study of the game theory behind the Prisoner's Dilemma and variations thereof. Not for the mathematically challenged.)

Rasmusen, Eric. *Games and Information*. 2nd ed. Cambridge, MA: Blackwell Publishers, Inc., 1989. (A textbook that contains mathematics accompanied by easily understood verbiage about the Tit-for-Tat Strategy and other game strategies.)

Ricks, Thomas E. and Roberto Suro. "The Wheels Turn in Army Strategy: Transformation to Cut Tanks' Role." *Washington Post*, 16 Nov., 2000:1.

Rossi, Peter H. and Howard F. Freeman. *Evaluation: A Systematic Approach*. Newberry Park, CA: Sage, 1989. (The author discusses policy evaluation techniques; good background reading on policy analysis.)

Rosenbloom, David H. *Public Administration: Understanding Management, Politics, and Law in the Public Sector*. 2nd ed. New York: Random House, 1989. (An undergraduate text that emphasizes the U.S. Constitution's elegant separation and balance of power.)

Simmons, L. Dean. (S) *Assessment of Alternatives for the V-22 Assault Aircraft Program (U)*. Alexandria, VA: Institute for Defense Analyses, June 1990. (The five-volume study, plus executive overview, classified Secret, is available in the classified library of the U.S. Naval War College, under call number U390 15 R-371 (S).)
