CONTRIBUTORS

J. Boone Bartholomees, Jr. (Ph.D., Duke University) is Professor of Military History in the Department of National Security and Strategy at the U.S. Army War College. He is a retired Army Colonel and the author of *Buff Facings and Gilt Buttons: Headquarters and Staff Operations in the Army of Northern Virginia, 1861-1865*.

Douglas A. Borer (Ph.D., Boston University) is an Associate Professor in the Department of Defense Analysis at the Naval Postgraduate School. He recently served as Visiting Professor of Political Science in the Department of National Security and Strategy at the U.S. Army War College. Previously he served as Director of International Studies at Virginia Tech, and has taught overseas in Fiji and Australia. Dr. Borer is a former Fulbright Scholar at the University of Kebangsaan Malaysia, and has published widely in the areas of security, strategy, and foreign policy.

Clayton K. S. Chun (Ph.D., RAND Graduate School) is Chairman of the Department of Distance Education of the U.S. Army War College and holds the General Hoyt S. Vandenburg Chair of Aerospace Studies. He was recently the Professor of Economics in the Department of National Security and Strategy. Dr. Chun is a retired Air Force officer with missile, space, command and control, strategy, and education assignments. He has published on a number of national security, economics, and space related issues.

Martin L. Cook (Ph.D., University of Chicago) is Professor of Philosophy at the U.S. Air Force Academy. He previously taught at the U.S. Army War College, Santa Clara University, the College of William and Mary, and numerous other educational institutions. Among other works, he is author of *The Moral Warrior: Ethics and Service in the U.S. Military*, SUNY Press, 2004.

Robert H. Dorff (Ph.D., University of North Carolina-Chapel Hill) is Chairman of the Department of National Security and Strategy, and Professor of National Security Policy and Strategy, at the U.S. Army War College where he has also held the General Maxwell D. Taylor Chair of the Profession of Arms. A graduate of Colorado College, he previously held faculty positions in the Department of Political Science and Public Administration at North Carolina State University and Michigan State University. He is the author or co-author of three books and numerous journal articles, many of which focus on U.S. national security strategy, democratization and failed states, and peace support operations. His most recent publication is *The Search for Security: A U.S. Grand Strategy for the Twenty-First Century* (co-editor) .

Reed J. Fendrick (M.A., Cornell University) is a senior Foreign Service Officer with the U.S. Department of State where he has served since 1974. He has been on detail as Faculty Advisor/Instructor to the Department of National Security and Strategy at the U.S. Army War College since July 2002. A graduate of the University of Wisconsin-Madison, he received the M.A. degree in Government from Cornell University. Among his diplomatic assignments, he has been Deputy Chief of Mission and Charge d'Affaires at the

American Embassy in The Hague, the Netherlands; Political Counselor at the American Embassy in Pretoria, South Africa; Deputy Director of the Office of Central African Affairs; Pearson Fellow assigned to the Office of International Relations of the Governor of Hawaii; Political Officer in the American Embassy in Paris, France, Pretoria, South Africa, the American Embassy in Bridgetown, Barbados and the U.S. Mission to the United Nations; Deputy Principal Officer at the American Consulate-General in Alexandria, Egypt; Junior Officer at the American Embassy in Rabat, Morocco; and Staff Assistant to the Assistant Secretary of State for African Affairs. In July 2004, he will report to the U.S. Mission to the United Nations where he will serve as Counselor for Political Affairs.

James A. Helis (MA, University of Pennsylvania) is the Director of Military History and Strategy in the Department of National Security and Strategy at the U.S. Army War College. He is a U.S. Army Colonel of Infantry and has served in command and staff positions to include the Department of Peacekeeping Operations at the United Nations Headquarters in New York.

James F. Holcomb (MA, Georgetown University) is a Faculty Instructor in the Department of Distance Education at the U.S. Army War College. Prior to his retirement from the Army in 2002, he taught for five years as Director of Military Strategy in the Department of National Security and Strategy. He also teaches the elective in Grand Strategy and the Strategic Art to the Resident Course at the War College.

David Jablonsky (Ph.D., Kansas University) is the Professor of National Security Affairs in the Department of National Security and Strategy at the U.S. Army War College and a retired U.S. Army Colonel of Infantry. A graduate of Dartmouth College and the U.S. Army War College, he received an MA from Boston University in international relations and holds MA and Ph.D. degrees in European history from Kansas University. He has held the Elihu Root Chair of Strategy and the George C. Marshall Chair of Military Studies at the Army War College and currently holds the Dwight D. Eisenhower Chair of National Security Studies. He is the author of five books, eight monographs, and numerous articles and book chapters dealing with European history and international relations.

Frank L. Jones (MPA, State University of New York at Albany), a career member of the Senior Executive Service, is Principal Director for Strategy, Plans and Resources in the Office of the Assistant Secretary of Defense for Homeland Defense. He has served in several other capacities in the Office of the Secretary of Defense including Deputy Assistant Secretary of Defense for Special Operations Policy and Support. He was Visiting Professor of Defense Policy at the U.S. Army War College, 2001-03. His articles and creative writing have appeared in a number of professional and literary journals.

Gabriel Marcella (Ph.D., University of Notre Dame) is Professor of Third World Studies and has served as Director of the Americas Studies in the Department of National Security and Strategy of the U.S. Army War College. His government experience includes service as International Affairs Advisor at the U.S. Southern Command. He has written extensively on Latin American security issues and U.S. policy, as well as the interagency process and national security. He is a consultant to the Departments of Defense and State. Current research focuses on the Colombian conflict and U.S. strategy.

Thomas W. McShane (J. D., Pepperdine University) is a U.S. Army Colonel and Director of National Security Legal Studies in the Department of National Security and Strategy at the U.S. Army War College. His Judge Advocate General experience includes service with the 101st Airborne Division in the Gulf War and as Staff Judge Advocate for the Southern European Task Force during NATO's Kosovo campaign. He taught criminal law and procedure at the Army's Judge Advocate General's Legal Center and School, has written articles for *Parameters* and *The Army Lawyer*, and addressed military and civilian audiences in the United States and overseas.

R. Craig Nation (Ph.D., Duke University) has served as Professor of Strategy and Director of Russian and Eurasian Studies with the Department of National Security and Strategy, U.S. Army War College, since 1996. His most recent major publication, a history of the Balkan conflict of the 1990s, is entitled *War in the Balkans, 1991-2002*.

George E. Teague (MA, Tennessee Technical University) is the Director of Military Strategy in the Department of National Security and Strategy at the U.S. Army War College. He is a Colonel in the U.S. Field Artillery and has served in a variety of operational and staff assignments, to include command of the 1st Battalion, 7th Field Artillery in the 1st Infantry Division and service as Chief of Operations in V Corps G3. Additionally, he served on the faculty in the Department of Behavioral Sciences and Leadership at the U.S. Military Academy, and in the National Security Decisionmaking Department of the U.S. Naval War College. His recent areas of research include the role of non-state actors in international relations and the influence of human factors in national security decisionmaking. He has written articles and case studies for use in the curriculum of both the U.S. Army War College and the U.S. Naval War College.

John F. Troxell (MPA, Princeton) is the Director of National Security Studies in the Department of National Security and Strategy at the U.S. Army War College. He is a U.S. Army Colonel combat engineer and has served in a variety of operational and staff assignments to include the Department of the Army War Plans Division and as a force planner for the Assistant Secretary of Defense for Strategy and Requirements. He has published articles and monographs with the *Strategic Studies Institute*, *Parameters*, and *Military Review*.

Professor Williams has also held the Walter B. Smith Chair of National Intelligence Studies at the U.S. Army War College since 2001. He has 30 years experience as an intelligence officer with the

Central Intelligence Agency, during which time he has held various senior positions with the Agency, the U.S. Intelligence Community, and in other departments of the U.S. Government. He received his BA from Old Dominion University, his MA in History from the University of Virginia, and subsequently his Certificate of Ph.D. Candidacy in Russian and European History from the University of Virginia .
